Instructions: Please first create a 'Cynthia Green Tomatoes For MT5' folder on your desktop and download/save the Files & PDF into this folder for easy access later. (Right mouse click on your desktop, click New >Folder, name it and move this PDF & all downloaded files into the folder.) (A free Dropbox dot com is better so you don't lose the files in case of a hard drive crash.)

EACH FILE BELOW SHOULD BE DOWNLOADED OR MOVED INTO YOUR 'CYNTHIA' FOLDER. The indicators and template files are zip files which needs to be unzipped after downloading, and then all indicator/template files copy/pasted into the correct Indicator/Template folder in your MT5.

[CLICK HERE](#) to download your Basic Green Tomatoes For MT5 Indicators into your 'Cynthia' folder and unzip before use.

In your 'Cynthia' folder, unzip the Indicator file, and then select to highlight all of the indicator .ex5 files and COPY ALL, THEN:

1. In top left corner of your MT5, go to File > Open Data Folder > MQL5 > Indicators.
2. Paste the .ex5 indicator files into the Indicator folder.
3. Go to Navigator/Indicators on the left and right mouse click inside the area and choose 'refresh'.
4. Your Indicators can now be found under Navigator/Indicators AND ARE ALREADY LOADED ONTO YOUR BASIC TEMPLATE.

In your 'Cynthia' folder, unzip the Templates file, select to highlight the template .tpl files and COPY ALL, THEN:

1. Open your MT5 platform
2. Go to File > Open Data Folder > MQL5 > Profiles > Templates.
3. Paste the .tpl template files into the Template folder.
4. Go to Navigator/Indicators on the left and right mouse click inside the area and choose 'refresh'.
5. Your template can now be found on your chart, right mouse click on a chart and select your Basic white or black template to apply to a selected chart.

NOTE: After you've copy/pasted your files into your MT5 in the proper folders, and you apply one of the Templates, if you have a chart that is a black screen and says 'Waiting For Update', it means the symbol name from my broker isn't supported by your broker, but if you look under Market Watch, find the corresponding symbol and drag it onto your chart... then the chart will load normally.

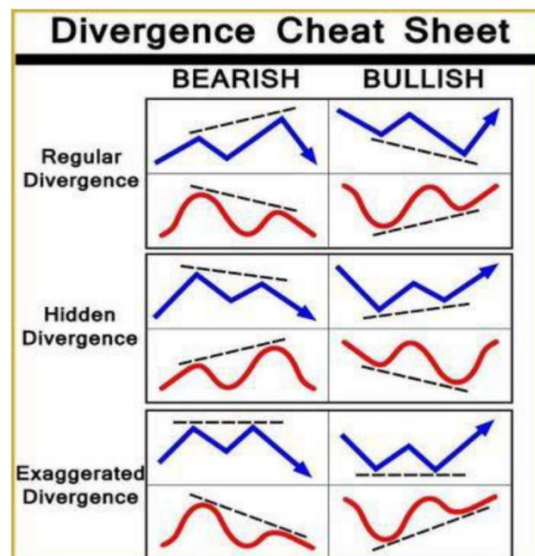

DIVERGENCE CHEAT SHEET

Here's a chart that shows you the different kinds of divergence...the blue is price action and the red is momentum...

**momentum is always a leading indicator,
PRICE FOLLOWS MOMENTUM:**





The Wildhog RSI with Divergence arrows is found in the Basic & PRO Green Tomatoes For MT5 (GT MT5), and is in the volatility window below the main window. Divergence arrows are predictive.

In this picture, the Volatility window has the Wildhog RSI and when the RSI line crosses the gold 50% line, it's a buy or sell signal, but all colors and all indicators must agree. I put the vertical red and green lines on the chart to show you how all the indicators must line up and agree when you want to sell (red line) or buy (green line). The short slashed white lines show you where I exited.

You can enter and exit at the Key Levels or Fibonacci Pivot Points for simplicity of trading. Use the Supply & Demand colored zones in conjunction with Key Levels for the best entries and exits.

You can also exit a buy trade at the red 85% overbought RSI level when the color line changes color...same for a sell trade, exit at the green 15% oversold RSI level when the colored line changes color. Confirm exit with the Hull colored line in the main window when it changes color. The big gold Reversal Fractal Arrow appears after the Hull colored line changes color.

The candles will turn grey when trend and momentum slow down and the volume bars will also decrease and change color.

ECN stands for Electronic Communication Network, and ECN brokers are true brokers that connect you with the banks. During the news, they will usually not give you fills before the spike, but within a few seconds of the spike, their spreads will become normal, and you will be able to open and close trades with normal spreads.

Trading volume is what they are after, they make their money on your trade volume, so there is no need for them to cheat you via re-quoting or stop loss treachery ... entry and exit is a breeze! They love scalpers and scalping robots because of the trading volume.

Scalpers and scalping robots need to use ECN brokers because the spreads are tighter, there is no re-quoting of price, the trade execution is faster and the latency is less lagging.

Robots AND scalping need a stable internet and electricity environment.

for your robots or scalping, this is what I've used for 14 years:

Living on the beach in Mexico, my electricity and internet go out
unexpectedly all the time.

To combat this and to make my trading safe, I actually trade out of my VPS
and always use my trailing stop EA trade manager... so if I can't get back in
for minutes or even hours, I know my trades are safe, with my trade manager
managing the trades.

The Green Tomatoes For MT5 PRO template has all the indicators
that are in the Basic template....plus these important indicators:

➔ **The Forex Factory Red News Alert Calendar:** it shows the red news events
scheduled for that day or the next, with a popup alert 30 min before. Never again get
caught being unaware! PRO TRADERS make their trading week scheduled around
red news events;

➔ **a Currency Strength Meter indicator** that shows the strength or weakness of
each of the 8 currencies... sell the weak and buy the strong, as a pair;

➔ **a 4 Time Frame color coded dots indicator** that shows M1 to M30 trends... the
dots are adjustable for higher time frame trading;

➔ **and a Risk to Reward indicator** that you can adjust the virtual take profit and
stop on your chart to see your Risk to Reward ratio.

OTHER RECOMMENDED MT4/MT5 TRADE MANAGERS

I'm not including my own trade manager in Green Tomatoes For MT5, since it still needs to be re-coded for MT5, I'll get to that down the road.

So instead, I'm recommending Jeff Glenellis 's three trade managers that work on both MT4 and MT5 and all currencies, indices, metals, and oils:

The ChartTraderv3 for MT4/MT5

The ChartTraderv3 for MT4/MT5 is the most basic trade manager and is very simple to use, 1 click sets your trade, trail and stop:

Auto Scaler Trade Manager for MT4/MT5:

If you want to place additional add-on trades to take advantage of a strong trend for the same pair.

I highly recommend that you pick up this most sophisticated MT4/MT5 trade manager trailing stop EA called the Auto Scaler, created by a respected colleague of mine, Jeff Glenellis:

The AutoScaler Trade Manager automatically places multiple pending trades going in the same direction on a pair. Add-on trades only get triggered if the price moves strongly enough and you can choose your pip steps and trail...

the trade management is brilliant and can easily and effortlessly increase your gains by trailing and closing multiple trades per pair according to your settings. Comes with PDF and training videos. Not recommended for use with Indices, but works great with currencies with a strong trend capability.

NEW! V3 AUTOSCALER-P STRADDLE MT4/MT5 TRADE MANAGER!

With one click, place Pending Hedge trades ahead of red news events!

You can set it up for red news events, it will trigger your pending trades even while you're asleep! If one side of the trade is triggered, it automatically closes the hedge side of the trade. It has a stop and trailing stop. Use conservative lot sizes so you can use it worry-free! If your live account is big enough, one trade can pay for it, it's that amazingly profitable! NOT FOR USE ON PROP FIRMS!
